PRESENT APPOINTMENT: Consultant Anaesthetist and Pain Specialist

I have a specific interest in all aspects of adult pain relief and/or rehabilitation from painful conditions. I cover a population of approximately 300,000 in the NHS and also engage in private practice and medicolegal work at the Grosvenor Nuffield Hospital Chester, Spire Cheshire Warrington and Chester Wellness Centre. I have been engaged in medicolegal work related to pain management since 1996 and have developed a specialist interest in this over the past 2 years. I have attended a number of lectures related to the subject at The British Pain Society national meetings and locally. I attended 3 expert witness courses in 2011 and one in 2012 and 2013. I have written many reports usually for claimants in personal injury cases but also defendants and have also written reports costing individual treatment programs usually on behalf of claimants with conditions involving pain and have delivered such treatment programs. I am also developing an interest in clinical negligence and have taken instructions on such cases. I realise that clinical work often makes it difficult to deliver timely medico-legal reports and I have therefore curtailed a considerable amount of private clinical work in order to pursue my medico-legal work more effectively with effect from April 2013.

I regularly attend important national and local meetings related to pain management and have talked at a national pain symposium in 1997, 2007, 2009 and given numerous lectures to GPs, nurses and trainees. I am continuously involved in training, am a member of the Merseyside Pain Training Committee and involved in training of GPs, nurses and patients. I have given numerous lectures or talks on the subject with excellent feedback.

In recent years I have also been traveling to major international conferences and courses on pain management including the World Pain Congress Montreal September 2010. Therefore I have kept myself on top of all recent developments. I received my initial training in pain on the Manchester training rotation mostly at the Hope Hospital Salford.

At the same time as all this I continue with the usual "bread and butter" service i.e. medical management of all varieties of pain (where appropriate) in the NHS. This includes local anaesthetic blocks, epidurals (cervical, thoracic and lumbar), facet joint injections, sympathectomies, stellate ganglion blocks and radiofrequency treatments.

Although the above are my main interests I have extensive experience of all aspects of DGH anaesthesia and do regular on calls as well as 4 sessions a week in theatre for the NHS coupled with at least 2 extra private sessions a week on average. I particularly specialise in regional anaesthesia and local blocks but am at home with anaesthesia for any operation likely to be encountered in a DGH. I have curtailed the anaesthetic private work in order to more effectively pursue medico-legal work and will shortly be a full time pain management specialist with no anaesthesia component.
